### **MERCHANDISE**

Alayna will sell various merchandise (CD's, photos, etc.) before and after the show. It is also understood that Alayna will keep 100% of the revenue generated from merchandise sales.

**DRESSING / GREEN ROOM** (depending on type of venue) Please provide 1 NON-SMOKING dressing / green room(s) which shall be:

- Clean, private
- Located close to the stage or performance area
- Located close to private bathroom facilities with running water
- Furnished with working electrical power
- Furnished with working A/C and heat
- Furnished with 8 bottles of water
- Purchaser shall be solely responsible for the security of all items in the dressing rooms and agrees to keep all unauthorized persons from entering the dressing room/ backstage area. ARTIST reserves the right to

approve who is allowed in the backstage and dressing room area.

### **PARKING/LOAD IN**

Please provide parking close to the stage for all vehicles associated with the ARTIST. Please provide this at no cost to the ARTIST.

### **STAGE**

Purchaser agrees to provide stage of reasonable size and layout to support performance requested. See Addendum for Stage Plot.

### **TICKETS** (not applicable if "free/no charge" event)

Purchaser agrees to provide ARTIST with (x) of complimentary (free) tickets to be used at the ARTIST'S discretion for their special guests.

### **PROMOTION**

Purchaser shall be responsible for all matters pertaining to the promotion and production of the scheduled performance including, but not limited to, venue rentals, security and advertising.

Purchaser agrees to reasonably promote the performance through its usual course of promotion and advertising efforts. Purchaser

agrees to help coordinate promotion activities of ARTIST'S Publicist as well.

### **INCLEMENT WEATHER**

In the event this show is not presented due to inclement weather, the ARTIST shall be paid in full, provided the ARTIST is present and ready to perform at the designated time and location specified in this contract.

### **CANCELLATION**

Purchaser shall give no less than seven (7) days' notice to ARTIST of cancellation of performance. If Purchaser cancels more than seven (7) days before agreed performance date, Purchaser agrees to pay ARTIST one-half (1/2) of the guaranteed fee. If Purchaser cancels less than seven (7) days prior agreed performance date, Purchaser agrees to pay ARTIST the FULL guaranteed fee.

### **TAXES**

Buyer agrees to prepare and file all tax information required of a person who hires an independent contractor and Artist agree that they have sole responsibility for the payment of any federal and state taxes arising from the monies paid by Buyer to Artist for the Performance.

## **INDEPENDENT CONTRACTOR**

Artist acknowledges that they shall perform their obligations hereunder as an independent contractor and not as an employee of Buyer. Artist further acknowledge that they are not on Buyer's payroll nor social security or tax withholding rolls. Artist shall have sole control and direction in the conduct of the performance.

## **AUTHORITY TO EXECUTE**

The signature below who is executing this Agreement on behalf of Artist hereby warrants and represents that he/she has the full power and authority to represent and bind Artist and acknowledges that Buyer is relying on said representation.
